



MEMORANDUM OF

UNDERSTANDING

This Memorandum of Understanding (MoU) is effective as of January 1st, 2021 (Effective Date) to establish an affiliation between SHRI G.S. INSTITUTE of Technology and SCIENCE, Indore (SGSITS Indore M.P. 452003, having its office at 3, Sir M. Visvesvaraya Marg. Indore. Hereinafter referred to as SGSITS, the "FIRST PARTY," Represented herein by its Director (Dr. Rakesh Saxena) (hereinafter referenced as "First Party." the institution which expression, unless exclusive by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

AND

NATIONAL AUTOMOTIVE TEST TRACKS, NATRAX PITHAMPUR, having an office at Agra-Mumbai Highway (NH-3), Next to Pithampur Flyover Post: - Khandwa District, Madhya Pradesh 454774, hereinafter referred to as NATRAX, the "SECOND PARTY", and represented herein by its Additional Director and Centre Head (Dr. N. Karuppaiah) (hereinafter referred to as "Second Party", company which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

The aforesaid parties are hereinafter referred to individually as Party and collectively as Parties.

SGSITS and NATRAX have many areas of common interest in Engineering Research and Training. In some of these areas, the degree of mutual interest is so great that considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education, training, and research by sharing of resources. The collaboration will be established within the principles set out in the following sections.

1. Object:

Both SGSITS and NATRAX agree to develop the following collaborative activities in the academic areas of mutual interest, on the basis of equality and reciprocity. The two parties shall seek to promote:

A. On the part of NATRAX: Field training/ Education of students

1. Training of Postgraduate (Students of Mechanical Engineering Department) on various aspects of vehicle designing, analyzing, assembling and manufacturing.

- 2. Internship opportunities to be provided to UG/PG students of the mechanical engineering department will be arranged with the mutual consent of both the parties.
- 3. Educational tours of the students will be arranged by the mutual consent of both the parties.

B. On the part of SGSITS

- 1. To select students for Internship.
- 2. To formalize the training schedule according to the college academic calendar.
- 3. To provide logistics support by way of the use of its auditorium and other such facilities in case of lecture series or expert lectures organized by NATRAX in association with SGSITS.
- 4. Participation in seminars, symposiums, and other types of academic discussions.
- 5. To organize joint seminars, conferences, or workshops on topics of mutual interest and to invite each other's resource persons / experts to participate therein.
- 6. The Second Party can use college resources (Labs and Equipment's) to build their projects which are directly connected with a student.

2. Coordination:

Each party shall appoint one member of its teaching/research faculty to coordinate the program on its behalf. Further, a coordination committee consists of (a) Head of the Department (Mechanical Engineering Department), (b) Department coordinator of SGSITS Indore, and (c) General Manager skill Development Program coordinator from the side of the second party will periodically review and identify ways to strengthen cooperation between two parties.

3. Confidential Information:

SGSITS & NATRAX both will adhere to the confidentiality clause of any and every information shared during the tenure of this MOU as per the law of the land including the Intellectual Property Right.

4. Validity:

The Memorandum shall remain in force for a period of <u>3 years</u> commencing from effective date 1^{st} January 2021. The parties may extend the term by written agreement signed by both after review.

5. Termination:

Either party may terminate the MoU by giving written notice of <u>1 Month</u> in advance to the other party once terminated, neither SGSITS nor NATRAX will be responsible for any losses, financial or otherwise, which the other parties may suffer. However, SGSITS and NATRAX will ensure that the provisions of this Memorandum shall continue to apply to all activities in progress until their completion.

6. Amendments/Modifications:

This MoU may be amended by the representative of both parties with mutual consent.

7. General Points of Agreement

Participating faculty & staff members, and students involved in any activities under this Memorandum must adhere to the law of the land and rules and regulations of the parties.

The MOU does not imply any kind of financial obligation, unless agreed upon in writing, on either side through separate agreement on case-to-case basis and neither party can claim for any financial charges.

Nothing in this Memorandum shall be construed as creating any legal relationship between the parties. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

Neither party shall be liable for any indirect, punitive, special, incidental, or consequential damages arising out of or in connection with this understanding, whether for breach of this

MoU or in torts, including loss of business, data, revenue, and profits or for any third-party claims against the other whatsoever.

All the disputed, controversy, or claims related to or arising in connection with this MoU shall be referred to the Competent Authority of Parties for an informal Solution.

SGSITS and NATRAX welcome the establishment of this Memorandum for cooperation and jointly agree to the provisions as set out above.
