


Sub: Online Registration fees for B.E./B.Tech.(Sem. IV,VI & VIII) /B. Pharmacy (IV,VI & VIII), M.E./ M.Tech., MCA (IV Sem.) Regular AB Group/Regular Repeater students for the semester Jan.-2025 to June- 2025 of the session 2024-25.

1. All UG/PG Students seeking admission in current semester are required to register themselves by online payment of semester registration fees as per following schedule through Institute's web portal www.sgsits.ac.in>Student Login> Student Services >Registration Form. Students should take the print of payment receipt and keep the same for future reference.
2. Before taking online registration, they should also make sure that they have returned all library books and have cleared library dues, hostel and other dues, failing which they will not be able to open the registration form.
3. It is mandatory for all eligible students to take online registration through Institute Portal Only.
4. In case of any problem the student should contact 0731-2582125, 0731-2582101. Attendance in the classes will be marked only for those students who take semester registration. The students are not permitted to appear in Mid Semester test if not registered for the current semester.
5. Students who pay fees by taking Education Loan are required to register themselves by online payment of semester registration fees as per following schedule through Institute's web portal www.sgsits.ac.in>Student Login>Student Services>Registration Form>Payment option>NEFT/ RTGS. Then generate the challan which has a payment virtual id on it. Show this challan to your Education Loan Bank for making payment of semester fees. A copy of RTGS/NEFT transaction no./receipt is to be submitted in the account section to Ms. Vaishali Kapdi mentioning name/enrolment/ mobile no/sem.
6. Do not download NEFT/RTGS form from google/Internet. Only the NEFT/RTGS form downloaded from student portal will be valid.
7. Do not transfer any semester fees into the Institute Bank Account directly in any case.

After 28/02/2025, student will be permitted by Director/Dean for registration

8. All the students who have dues for any of the past semester must clear it before registration in the current semester. From this semester onwards no students will be entertained for renewal of registration unless past dues are cleared.
9. All Students should note that classes for the current semester as per the academic calendar.
10. All Students should note that:
Minimum 75% attendance is compulsory for appearing in End Semester Examination and getting any scholarship.
11. OBC/SC/ST students who are eligible for Post Metric Scholarship on family income basis, are required to fill online Post Metric Scholarship form on www.scholarshipportal.mp.nic.in, and hard copy along with all enclosures to be submitted to Post Metric Scholarship (PMS) Section of the institute for further forwarding to Govt. of M.P. for refund/reimbursement of fees and post metric scholarship amount in students bank accounts directly. Any queries regarding Post Metric Scholarship the students have to contact PMS section (Accounts Section) of the institute.
12. Those Students who are not eligible or not promoted to higher semester/year, their fees will be returned back or adjusted later on.
