II. **DEFINITIONS:**

(B)**Foreign National(FN):** Citizens of all Countries other than India, who are not of Indian origin as defined under PIO.

(D) **Overseas Citizen of India (OCI) :** A person registered as Overseas Citizen of India (OCI) Cardholder under section 7A of the Citizenship Act, 1955.

(C)**Children of Indian Workers in Gulf Countries (CIWGC) :**Children of Indian workers serving in the Gulf Countries. Give Certificate of Employment of Mother/Father

III. **BASIC ELIGIBILITY CRITERIA:**

The candidates shall be considered for admission to First Year **B.Tech./ B. Pharma. (4YDC)** against **FN, OCI and CIWGC** seats who have passed the qualifying examination(i.e. Class 12th of 10+2 System) or equivalent examination with Physics, Chemistry & Mathematics subjects.

IV. The application in prescribed proforma must be sent to the Institute along with:

1. Marksheets of class 10th and 12th class of 10+2 system of Board of Secondary Education Madhya Pradesh or equivalent examination from recognized institution.
2. Transfer Certificate issued by School/ Institute last attended.
3. Character Certificate issued by School/ Institute last attended.
4. Migration Certificate issued by Board/ University.
5. Aadhar
6. A certificate proving /FN /OCI/ CIWGC status.
7. A certificate from Employer/ Competent Authority of the Organization, where working which includes Designation, Salary, Contract of Service etc.
8. Certificate of annual income of Father/Mother/Guardian.
9. An affidavit sworn before Consulate/ Embassy by the mother/ father of the candidate.
10. NRI Certificate duly issued by concerned Embassy.
11. Photographs of candidate – 4 Nos.
12. Medical Fitness Certificate by the Registered Medical Practitioner.
13. Gap-Certificate (in case of gap in education).
14. Mediclaim Policy must be produced at the time of admission in the institute.
15. Please bring two certified photocopies of all the documents & four photographs at the time of Admission.

- V. The completed application in prescribed proforma must reach the office of The Director, Shri G. S. Institute of Technology & Science, Indore, 23, Park Road, Indore on or before the dates declared in the notification either in person or by post.
- VI. The admission will be made on merit basis for which the counseling will be held on the dates declared in the notification in the Institute.
- VII. The candidate shall be required to report to the Institute along with his/her Father or Mother or Local Guardian to the Institute to complete formalities of admission from on the date of counseling. If father and mother both are not alive, then the signature of the Guardian shall be allowed and admitted on the declarations, provided proper certificate of Guardianship is produced.
- VIII. The candidates shall be required to deposit the fee of US\$ 3000/- per year plus Caution Money of US\$ 1500(refundable) payable once, plus all other fee and guarantees as per rules as a Pre-requisite for admission. The Candidate is therefore required to bring certified Bank-References for paying capacity.
- IX. The provision of Transfer from one Institute to other Institute in M.P. shall not be applicable.
- X. The hostel-accommodation shall be available as per Institute rules applicable in such cases.
- XI. Photocopies of all relevant documents must be self attached.
- XII. The candidate must submit School/College Leaving Certificate (Transfer Certificate) & Migration Certificate in original at the time of admission or within seven days of his admission.
- XIII. The candidate must attend all the classes regularly. If here mains absent continuously from the classes form or e than fifteen days, his admission is liable to be cancelled.
- XIV. For any dispute in connection with your admission, the interpretation given by the Director of the Institute shall be final. The jurisdiction of the Court of Law at Indore shall be binding for judicial review in all matters related to it or arising out of it.
