- (i) Institute took necessary steps to meet the performance benchmarks laid by NPIU for digital initiatives. [Registration on Vidwan Portal, Access to Digital resources of NMEICT, Swayam, MOOCS, NPTEL, Virtual Laboratory ]
- (ii) The performance benchmarks till 30<sup>th</sup> June 2020 are met by the Institute.
